These Terms and Conditions are the 2019 Brighter Days Festival Raffle rules.

By entering the 2019 Brighter Days Festival raffle, all entrants agree to be bound by these rules.

- The Raffle will be drawn at Sibley Sound Shell, Howitt Park, Bright VICTORIA 6pm 10th March 2019.
